# EXECUTIVE MASTER – Mastère Spécialisé® MANAGEMENT OF ENERGY PROJECTS

## **Supporting Documents**

- An identity photo
- A copy of a valid Identity Card or a Passport identification page
- A detailed and updated Resume in English
- A motivation letter in English
- Detailed degree grades for the last degree obtained
- A copy of your last diploma (Certified French translation for foreign diploma to be submitted before admission). Future graduate applicants should indicate the expected graduation date
- Type of tuition fee funding: Personal funding, funding supported by your company, bank loan, other...

English proficiency: The required level of English is equivalent to a B2 level (common European framework of reference for languages)

- \* If your native language is English, you do not need to justify your level of English
- \* If your native language is NOT English, you will be tested during the interview

## **Entry Requirements**

#### **Academic requirements**

- Master's Degree (Bac+5)
- Equivalent Diploma (Comparable to Bac+5)
- Bachelor's Degree (Equivalent to Bac+4) with three years of work experience.

**Future graduate applicants** can apply for admission to this Executive Master however their ongoing degree must be submitted to Ecole nationale des ponts et chaussées administration before the end of 2026.

#### Foreign/international applicants

We strongly recommend you submit your application documents at the soonest in order to facilitate your visa process. Candidates from 41 countries (outside EU) are required to follow the process of « Etudes en France ». ## **Selection Process**

The Admission Committee will examine all fully completed application forms with their supporting documents. Preselected candidates will be invited by mail for interview that will be held viaTeams.

All the process (Electronic applications, pre-selection, invitation to interview, final decision) will be managed by e-mail. You are invited to regularly check the spam file of your mailbox to make sure none of our mails landed there.

At the end of this selection process, the Admission Committee will validate the list of candidates to enter the program.

#### The first sessions are:

#### Session 1

Deadline for application submission: 25<sup>th</sup> January 2026 Interviews: 29<sup>th</sup> January 2026 Admission jury: 31<sup>st</sup> January 2026

#### Session 2

Deadline for application submission: 22<sup>nd</sup> February 2026 Interviews: 26<sup>th</sup> February 2026 Admission jury: 28<sup>th</sup> February 2026

# **Admission Confirmation:**

In order to confirm their admission to École nationale des ponts et chaussées, successful candidates must follow the following steps:

### In case of personal financing:

- Return the vocational training *contract within 30 days*, together with the proof of payment of the deposit of 20% of the training fee.

#### In case of company financing:

- Return the vocational training agreement within 30 days or send a letter of commitment from a company financing the training.

Failure to respect these deadlines results in the loss of the benefit of the selection, to the benefit of another candidate placed on the waiting list.

## **Tuition Fee**

The tuition fee for the 2024/2025 session of executive Master "Management of energy projects" is:

- o **14 500 €** if financed by the Applicant
- o **15 500 €** if financed by the Employer (founding partner and sponsors of the executive Master: Accuracy, Assystem, CGI, EDF, IFRADD, EGIS, Orano, Terega, ENGIE)
- o 17 000 € if financed by any other Employer.

These prices are exempt from VAT.

We advise candidates to make sure they have adequate funds to support one year of academic study as well as personal expenses. Average budget for living expenses is 1 290 euros/month (source UNEF, August 2024).

#### Please note:

The degree Mastère Spécialisé® (Executive Master) is an institutional degree accredited by the Conférence des Grandes Ecoles. It is not accredited by the French ministry of higher education.

The course is registered with the Répertoire National des Certifications professionnelles (RNCP), title "Directeur de projet en énergie" level 7 (RNCP38009). It is Datadock listed.

All incomplete application form will be rejected.
